#### **USEF SAFE SPORT TRAINING REQUIREMENTS TO COMPETE**

All USEF Life and Senior Active members, as well as participants who have regular contact with minor athletes, are required to comply with the U.S. Center for SafeSport training requirement to be eligible to participate in the competition. All participants must adhere to the U.S. Center for SafeSport Code, USEF Safe Sport Policy, and the Minor Athlete Abuse Prevention Policies. Every USEF adult member (18 years of age & older) with a Competing Membership must complete USEF's Safe Sport Training, overseen by the U.S. Center for SafeSport.

An adult member may be OWNER, RIDER, TRAINER and/or COACH. Adult members listed on the entry must complete the entire course and be Safe Sport Trained <u>by</u> the first day of competition. Safe Sport Training must be completed by all adult members on the entry or the rider will not be allowed to compete.

You may access the Safe Sport modules from your USEF member dashboard at www.USEF.org.

#### **SHOW NOTICE**

US EQUESTRIAN FEDERATION rules are in force from the moment show management allows access to the show grounds. This includes conduct, correct saddlery and equipment, and attire.

#### Entries:

Accepted on a first come, first serve basis by on-line entries only, see below for more information. This is a two show weekend. Each show requires a separate entry if entering both shows. One entry per horse/rider combination per show.

#### **On-Line Entries**:

Visit *HorseShowSolutions.com* or *EqEntries*.com opening day. Required documents are the USEF Entry Agreement, which is the second page of the entry form and requires signatures for everyone listed on the entry (see next page for the definition of a Trainer and Coach on the entry), a negative Coggins and current Flu/Rhino vaccination records. These documents may be uploaded in Equestrian Entries and submitted with the show entry or e-mailed separately to the Show Secretary. You must also provide the *USEF Waiver and Release of Liability Form* for everyone listed on the entry. If bringing a groom, the Waiver is required. These Waivers may be uploaded in Equestrian Entries and submitted with the show entry or e-mailed separately to the Show Secretary. Entries without current and correct association number verification will be considered incomplete and the membership verification fee applies for each entry.

Please note, the *USEF Entry Agreement* and *USEF Waiver and Release of Liability Form* may be found on the last 2 pages of this document. Both forms are PDF fillable forms. USEF will accept a typed name on the signature line and it will have the same validity, force and effect as a hand written signature. You must save each form with a different file name after completion. Otherwise, your information will not be saved to the updated forms.

*Management requires that all entries be created on EqEntries.com*. If you do not already have a user account with Equestrian Entries, please sign up. There is no fee to join Equestrian Entries to create an entry. You may pay on-line with a credit card or mail a personal check to the Show Secretary for the total entry fees. If you choose to pay online, there is a 5% fee plus a \$5.00 handling charge. If paying with a personal check you must inform the Show Secretary that you have created an entry in Equestrian Entries and will be mailing a check for the entry fees.

Each competitor is responsible for supplying show management with the correct, current and required association numbers of USEF and USDF for the horse, owner, rider/handler, trainer and coach (trainer and coach are exempt from USDF membership requirements), with their on-line entry. The scores of competitors who fail to supply correct and active numbers may not count towards national awards.

Any fees incorrectly charged to the entry and paid for with EqEntries will be refunded to the credit card used for the entry.

No telephone, mail, fax or e-mail entries will be accepted. ALL FEES MUST ACCOMPANY ON-LINE ENTRIES OR A PERSONAL CHECK MUST BE MAILED TO THE SHOW SECRETARY. Entries without payment in full will not be accepted.

On-line Entries must be received by July 16, 2021. Entries received after the closing date will be accepted **only if submitted and paid on-line** accompanied by a \$15 late entry fee per show on a space-available basis. <u>Personal checks will not be</u> accepted for late entries.

Only one horse/rider combination per entry form.

#### Entry to show grounds will NOT be permitted if any entry documentation is missing.

This includes current and active memberships, all required entry signatures, Coggins and Flu/Rhino vaccination records as well as waivers for all those named on the entry forms. The Show Secretary must receive all necessary missing documentation <u>by</u> Thursday, July 22, 2021 via e-mail. Competitors will **NOT** be allowed to enter the show office to fill out forms or provide paper copies – everything must be submitted electronically.

#### **COVID-19 Safety Precautions:**

BDS will comply with the guidelines regarding COVID-19 as set forth by USEF and the State of Montana at the time of the shows.

Please make sure to also familiarize yourself with the USEF COVID-19 Toolkit and understand your responsibilities as a Participant in this show, <u>https://www.usef.org/media/coronavirus-resources</u>.

#### Montana Coggins/Health Certificate Law:

**Equine residing in Montana:** A current negative Coggins for EIA conducted within 12 months of the show date is required. A Certificate of Veterinary Inspection is not required for Montana equine.

**Equine entering Montana:** All equine entering Montana must be accompanied by a current negative Coggins test for EIA conducted within 12 months of the show date and a Certificate of Veterinary Inspection issued by an accredited veterinarian within 30 days of entry.

#### **USEF Equine Vaccination Rule:**

Per USEF GR845 Equine Vaccination Rule; All equine entering this competition must provide with their entry, proof of current flu/rhino vaccinations within 6 months of the show BUT should be no later than 7 days before the show. If providing proof of vaccinations from your veterinarian it must be on the veterinarian's letterhead. E-mails without an attached letter from a veterinarian will not be accepted.

The horse name on the Coggins report and vaccination documentation MUST MATCH the horse's USEF registered name as listed on the entry form and on their USEF/USDF horse identification or recording documents, or it will not be accepted (USEF GR907.4).

#### **Equine Activity Liability Statute Warning**

A person is not liable for damages sustained by another solely as a result of risks inherent in equine activities if those risks are or should be reasonably obvious, expected, or necessary to persons engaged in equine activities. Montana Code Ann. §27-1-725 - 27-1-728

**TRAINER**, as listed on the entry form, is defined as any adult (18 years of age & older) who has responsibility for the care, custody or performance of the horse while the horse is on the competition grounds. This adult must sign the entry form as trainer.

*COACH*, as listed on the entry form, is defined as an adult (18 years of age & older) who gets paid for instructing, teaching, schooling or advising a rider with their horse on the competition grounds. This adult must sign the entry form as coach.

#### Non-Compete Horses:

A non-competing horse entry must pay the non-compete fee plus stabling and the office fee.

#### Credit Cards:

Credit cards will be accepted during the show for on-line purchases of shavings and hay at the HorseShowSolutions.com/ Purchase Now page. Contact Show Secretary with questions.

#### **Returned Checks or Declined Credit Cards:**

Checks returned by the bank or declined credit cards will be charged a penalty of \$50.00 or 10% of the face value of the declined amount, whichever is greater. Accounts will be given 10 days to be paid in full with cash or equivalent. Checks will NOT be deposited a second time. See USEF GR913 Unpaid Entries.

#### Great American/USDF Qualifying Classes:

Qualifying classes will not require a separate ride. All exhibitors riding in the Open, Adult Amateur, & Junior/Young Rider classes will pay an additional \$15 USDF fee to have this score entered in the USDF qualifying class at that level. No separate ribbons or prizes will be awarded. Please add the additional \$15 to the on-line entry form for the qualifying class.

#### Important notice to all affected parties:

Third parties, specifically those individuals listed on the entry form with the competitor, may come upon the property or enter the facility where any herein described or listed event will occur; provided, that this is a license to enter the premises, for the purpose of observing or participating in the event, but not otherwise, and such license to any individual is subject to revocation by the owner, lessee or organizer, and entry for any purpose other than granted herein, shall be deemed criminal trespass and subject to appropriate legal proceedings. If said parties fail to observe COVID-19 Guidelines, they will be asked to immediately leave the show grounds. No spectators are permitted to attend these competitions.

#### Pony Riders/Pony Measurement:

If you don't have a measurement card for the pony, you must notify the Show Secretary in writing with your entry. You will need to schedule an appointment to have this done prior to your first pony test and are required to pay the veterinarian fee for this service. Pony measurements will take place on Saturday morning between 7:30am and 10:00am. The competitor will be notified of their appointment time.

A pony does not exceed 148 cm without shoes and 149 cm with shoes. Any pony competing in classes limited to ponies must submit a copy of a USEF Measurement Card with each entry.

#### Confirmation/Times:

Unofficial ride times and show updates will be posted no later than the Thursday prior to the horse show at HorseShowSolutions.com. A Fox Village entry confirmation will be e-mailed to the rider.

<u>*E-mail addresses are required and must be active.*</u> It is the responsibility of the rider to inform show management of any time conflicts as soon as possible after reviewing the schedule.

Management reserves the right to change the time schedule after tentative times have been posted. A list of final ride times will be available at <u>https://horseshowsolutions.com/prize-list-show-info-2021/</u> and <u>https://www.foxvillage.com/Results.</u> Ride time will not be posted on the show grounds and will only be available electronically. This show follows USEF GR830 with regard to rescheduled ride times.

#### **Entry Cancellation/Refunds:**

Office fee is not refundable. Entries <u>with written cancellation</u> on or before the closing date will receive 100% refund of all fees minus the \$30 office fee. NO REFUNDS after Closing Date even if Closing Date is extended. If wait list entries cannot be accepted due to a full show, all fees will be refunded.

#### **Scratches During Show:**

Competitors have the responsibility to inform the Show Secretary by text or phone call of their intent to scratch a ride prior to the scheduled ride time. Scratches can be accepted at the competition arena with the Ring Steward <u>but the competitor or representative must send a text to the Show Secretary at 312.401.1157 or call after securing their horse to officially scratch their ride</u>. If texting or calling is a problem come to the show office to speak with the Show Secretary. Scratched rides are not refundable.

#### Adding a Class During the Show from a Scratched Ride:

Competitors may fill a scratched ride during the competition but must contact the Show Secretary first. Payment for an added class will be made by credit card on the HorseShowSolutions.com website page after the Show Secretary sends the rider a link from which to pay the added class fees. A post entry fee will be added to these classes entered during the show.

#### Show Schedule and Ride Time Conflicts:

It is the responsibility of the rider to inform the Show Secretary of any time conflicts as soon as possible after receiving the schedule.

\$10.00 per bale. Pre-ordered hay will be delivered to the stall prior to arrival. During the show, additional hay may be purchased on the HorseShowSolutions.com/Purchase Now website page by *noon each day*. No guarantees of same day delivery if ordered after 12pm.

#### **Stabling/Tack Stall Fees:**

Limited availability. Permanent indoor 12' x 12' wooden stalls with sliding doors, includes a latch to secure door and optional secured window. Water buckets, bucket hangers, bridle & saddle racks and manure removal equipment <u>not</u> supplied by the facility. You must bring your own. Competitors are responsible for stall damage. When not stabling, a haul-in fee of \$20 per day must be paid. This includes Friday if you haul-in to practice. Horses cannot be tied to fences. Tack stalls are not available for these shows.

Stable Groups: If stabling with a group provide one unique name to identify the group on each entry form for that group.

#### If competing at both shows, please enter horse stall fees for the show weekend on the Dressage Under the Big Sky III show entry form.

Available at \$30 per night with electricity. If leaving the show grounds at any time over the show weekend, a face mask/face covering must still be worn in a public environment. BDS COVID-19 Guidelines are still in force off show grounds property. Please be back on the property by 9:00pm as the entrance gate will close and you will be unable to enter the show grounds.

#### **Dry Camping Fee:**

Available at \$20 per night. No hookups. Tents are not allowed. If leaving the show grounds at any time over the show weekend, a face mask/face covering must still be worn in a public environment. BDS COVID-19 Guidelines are still in force off show grounds property. Please be back on the property by 9:00pm as the entrance gate will close and you will be unable to enter the show grounds.

#### Sharps/Medical Waste Disposal:

Competition management may fine any individuals including trainers, owners, exhibitors, or their agents up to \$100 for improper disposal of needles or other sharp disposable instruments. Containers to hold used syringes are located in the barn aisles and in the show office. Please do not use garbage cans for this material.

#### Safety Regulations:

Smoking or open-flame devices are not permitted within the stable area.

#### Arenas/Footing:

Outdoor competition arena is a Standard 20mx60m arena with sand-based footing. An outdoor sand-based arena will be available for warm-up on the east side of the competition arena, with a separate longeing area. Longeing is allowed only in the designated longeing area and not in the warm-up arena. Schooling may be permitted in the competition arena, weather permitting, on Friday and at the conclusion of scheduled competition rides in the arena each day. Management may elect to run some classes, Introductory & Training Level classes, in a small arena if necessary, provided the test is designed for a Small Arena.

#### No Shows:

All "No Shows" who have not contacted the show office will be considered a scratch for the rest of the show and time slots may be filled. Exhibitors enter with this understanding and agreement.

#### **<u>Riders Under the Age of 14</u>**:

No rider under the age fourteen is permitted to ride a three-year old colt, or stallion of any age, in any under saddle class including Dressage Sport Horse Prospect Under Saddle, Materiale and Suitability classes. DR202.14

#### Consecutive Levels:

Horses may enter no more than two consecutive levels, Freestyle levels included, at any one competition.

#### <u>Classes per Day</u>:

Horses are limited to a maximum of three Dressage rides per day at Fourth Level and below or two Dressage rides per day above Fourth Level. Horses competing at both Fourth Level and Prix St. Georges, or their equivalents, are limited to two Dressage rides per day. Dressage Seat Equitation, Quadrille, Pas de Deux and Materiale classes are excluded from the maximum limit of rides per day and horses in these classes may compete at any level for which they are otherwise eligible during the same competition.

#### **Property Damage:**

All owners and exhibitors will be held responsible for any damage incurred by them, their agents or employees to stalls, buildings and other property on the show grounds and shall be billed accordingly.

#### Leaving the Competition:

No exhibitor may withdraw horses from a licensed show after it has commenced, or remove them from the show grounds without permission of the Show Secretary.

#### Sound Checks for Musical Freestyle Rides:

MP3 is the preferred music format for freestyle music. Sound checks will be done during the lunch breaks on Saturday and Sunday. E-mail you music to Erika Gioscia, <u>erika@bozemandressagesociety.com</u>.

#### Freestyle Entry:

Except for USEF/USDF Championship classes and for FEI Pony Riders, FEI Junior, FEI Young Rider and FEI Para-Equestrian Freestyles, in order to enter a freestyle class at any level, a horse/rider combination must have received a minimum score of 63% for Training through Fourth levels and 60% for FEI levels in the highest test of the declared freestyle level or any test of a higher level at a USEF/USDF licensed Dressage Competition or FEI recognized Dressage Competition or "open" Dressage class (i.e. open to all breeds) at a Federation Licensed Competition held prior to the competition where the horse/rider combination is entered to ride a freestyle class. A photocopy of the test verifying eligibility, or copy of the USDF score verification, must be submitted with the entry for a freestyle class. DR129.9

#### Food:

Food and beverages will be available for purchase on the show grounds.

#### Medical:

Medical personnel will be on grounds. Ambulance on call.

#### Spectators:

Spectators will be allowed on the competition grounds and must follow the USEF COVID-19 Action Plan for spectators.

#### Dogs Must be On Leashes At All Times While On Show Grounds: (includes stable areas)

Dogs are not permitted to be loose on competition grounds and must be held on a leash or otherwise restrained. Individuals must not lead dogs on a leash while mounted. Dog owners are solely responsible for any damages, claims, losses or actions resulting from their dogs' behaviors. Dog owners failing to comply with this rule will be issued a Yellow warning card and may be subject to penalty under Chapters 6 and 7. (GR1301.6) No other pets or livestock other than horses/mules allowed on grounds.

#### Motorized Vehicle Statement:

In accordance with USEF GR1301.7 and GR1301.8: Minors who do not have a valid driver's license which allows them to operate a motorized vehicle in the state in which they reside will not be permitted to operate a motorized vehicle of any kind, including, but not limited to, golf carts, motorcycles, scooters, or farm utility vehicles, on the competition grounds of licensed competitions. Minors who have a valid temporary license may operate the above described motorized vehicles as long as they are accompanied by an adult with a valid driver's license. *The parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating a motorized vehicle in violation of this rule are solely responsible for any damages, claims, losses or actions resulting from that operation.* Violations of this rule will be cause for penalties against those responsible for the child committing the offense. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule. (GR1301.7)

The unsafe use of personal electronic transport devices, as determined by the competition officials and management in their sole discretion, that do not require a driver's license to operate, including but not limited to segways, hover boards, and single wheeled scooters is prohibited on competition grounds. Operating such devices in areas where people gather may be deemed "unsafe use" if there is a risk of harm to others. If the operator of the device is a minor, the parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating the device in violation of this rule is accountable and may be subject to penalties. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule. (GR1301.8)

#### Helmets:

DR 120.6. From the time horses are officially admitted to the competition grounds by competition management, anyone mounted on a horse at any time on the competition grounds, including non-competing riders, riders on non-competing horses, mounted participants in exhibition classes and those competing in all classes and tests, including Para-Equestrian tests, must wear protective headgear as defined by this rule and otherwise in compliance with GR801. Any rider violating this rule at any time must immediately be prohibited from further riding until such headgear is properly in place. Protective headgear is defined as a riding helmet which meets or exceeds ASTM (American Society for Testing and Materials)/SEI (Safety Equipment Institute) standards for equestrian use and carries the SEI tag. The harness must be secured and properly fitted. Unless jackets are waived, while in the competition ring, exhibitors wearing protective headgear must wear a short, dark jacket, dark tailcoat (only permitted for tests above Fourth Level), or Armed Services or police uniform (if eligible), dark hatcovers (where applicable) and must otherwise conform to DR120 (see GR801).

#### Awards:

Riders must clearly specify division choice. When no designation is made, riders will automatically be entered as Open. *Introductory through FEI levels* – Ribbons will be awarded 1<sup>st</sup> through 6<sup>th</sup> place in each division (Open, Adult Amateur, JR-YR) in each class. Qualifying classes (GAIG/USDF) are run concurrently with the division class and there will be no separate ribbons awarded.

*High Percentage Awards* will be awarded each day for each division (Open, Adult Amateur, JR-YR), and will be based on a simple high point percentage. Excludes Intro, Freestyle, Developing Horse, Young Horse, Dressage Seat Equitation, Materiale, Eventing and Opportunity class scores.

Other awards may be available by show time based on the number of entries received. All awards will be given at the show.

Ties will be broken in accordance with USEF DR123 - In case of equality of points the competitor with the highest marks received under General Impressions shall be declared the winner. When the scores for General Impressions are equal after coefficients have been applied, the horses must remain tied. DR123.3

#### Fly Hoods Are Permitted For All Classes, Indoor and Outdoor:

Fly hoods (ear covers) that do not cover the horse's eyes can be used to protect horses from insects. Fly hoods may not be attached to the noseband. They should be discreet in color and design, and may have a promotional or manufacturer's logo that is in compliance with DR121.1.1.2. Fly hoods are permitted in the warm up and other training areas and for all classes. Fly hoods may be noise-cancelling in manufactured state but cannot be used with earplugs. If a tack inspection is performed after completion of the test, the rider or his/her representative is responsible for removing the fly hood and presenting it for inspection to the designated ring steward who will ensure that nothing prohibited has been added, such as earplugs. Blinkers or goggles (with clear or colored full eye cups) and fly masks that cover the horse's eyes are permitted in the warmup but are prohibited in the competition arena. Cooling caps (hoods) are prohibited in competition and warmup areas. DR121.8

#### Ear Plugs:

Ear plugs and ear muffs are, under penalty of elimination, prohibited. Exception: Ear plugs are permitted at prize-giving ceremonies for horses competing at any level, including High Performance classes. DR 121.9

**Non-U.S.** Citizens and Foreign Competitors must provide proof, in English, of current membership in good standing in their respective National Federation, or hold current membership in good standing with the USEF and USDF.

#### Announcements:

Class announcements and ride time announcements are a courtesy to the exhibitor and not all shows provide the capability of public address announcements. Exhibitors are responsible for presenting themselves to the ring at their designated time and accept the full responsibility for doing so. Competitions offering public announcements will make every effort to maintain a working PA system, but it is stressed that it is still the exhibitors' responsibility to be on time. No protest will be upheld, nor any ride time changed, on the basis of a PA breakdown or missed announcement. Ring stewards will also make every effort to keep people informed and entering the ring in a timely fashion. Exhibitors are responsible for knowing the correct show time and their scheduled performance time regardless of PA announcements or ring stewards. No protest will be upheld, nor ride time changed due to failure of the exhibitor to meeting their responsibilities.

#### **Open Classes:**

A class that is open to all. There are no restrictions based on the horse (age, sex, size, residence or membership of owner) or rider (age, experience, qualifications, sex, residence, etc.)

#### Adult Amateur Classes:

Participants must possess a current USEF Amateur Card and qualify under the USEF Amateur rules. Any non-member that wishes to participate in the Adult Amateur designated classes must purchase a USEF non-member amateur card for \$45 from USEF. Open to Adult Amateurs only; riders must compete as adults from the beginning of the calendar year in which they reach the age of 22.

Beginning January 1, 2021, anyone born in 1999 will turn 22 and is considered an adult for the purpose of competing in a dressage competition.

#### JR/YR Classes:

Individuals are eligible as Juniors until the end of the calendar year in which they reach the age of 18. Individuals are eligible as Young Riders from the beginning of the calendar year in which they reach the age of 16 until the end of the calendar year in which they reach the age of 21. Competitors shall compete as Adults from the beginning of the calendar year in which they reach the age of 22. Individuals possessing current amateur certification are only eligible as Adult Amateurs from the beginning of the calendar year in which they reach age 22. DR119.3

For purposes of qualification for and participation in competitions conducted under FEI rules, age groups are as follows:

- a. Young Riders: Same as in DR119.3;
- b. Juniors: Individuals are eligible as Juniors from the beginning of the calendar year in which they reach the age of 14 until the end of the calendar year in which they reach the age of 18;
- c. Pony Riders: Individuals are eligible as Pony Riders from the beginning of the calendar year in which they reach the age of 12 until the end of the calendar year in which they reach the age of 16;
- d. Children: Individuals are eligible to participate in competitions and championships for Children from the beginning of the calendar year in which they reach the age of 12 until the end of the calendar year in which they reach the age of 14;
- e. A person may compete as a U25 Rider from the beginning of the calendar year in which he reaches the age of sixteen (16) until the end of the calendar year in which he reaches the age of twenty five (25). DR119.4

Must include birth date on entry form.

#### Adult Amateur Vintage Classes:

A restricted class which is not open to all. Adult Amateur Vintage Classes are open to any Adult Amateur rider 50 years of age or older. These classes are eligible as GAIG/USDF Regional Championship qualifiers.

#### Pony Classes:

Open to all breeds that meet the following measurement requirements. A pony is an animal that does not exceed 148 cm without shoes and 149 cm with shoes. The pony can be of any sex (mare, stallion, or gelding).

#### **USEF Show Pass (non-member) Fee:**

To be eligible to compete as a rider, handler, owner, lessee, agent, coach, or trainer at a USEF Licensed Competition an individual must be a USEF Senior Active, Junior Active, or Life member (GR201). Individuals unable to present proof of membership are required to complete a Show Pass Form and pay a fee in the amount of \$45 per show. Entries in Introductory and Opportunity classes are exempt from this requirement.

#### **USDF** Non-member Fee:

For each USDF non-member owner/lessee and USDF non-member rider, there will be a USDF non-member fee of \$35 per show. Entries in Introductory and Opportunity classes are exempt from this requirement.

#### **USEF/USDF Horse ID Requirement:**

All horses entered in USEF/USDF recognized shows must have at least a USDF HID (Horse Identification) number in order to participate. If riding in qualifying classes, you must have a USDF Lifetime Registration in addition to a USEF Annual or Lifetime Recording. Exempt from this requirement are horses showing in Introductory Level, Opportunity Classes, Pas de Deux, Quadrille, and exhibitions. These horse identification numbers may be obtained from USEF and USDF.

#### Hazardous Weather/Acts of God/Accident/Emergency Policy:

Management reserves the right to cancel any classes due to Hazardous Weather, Acts of God, Accidents or Emergencies. Every effort will be made to reschedule with priority given to any Championship or qualifying classes being offered. No refunds for cancellations due to Hazardous Weather, Acts of God, Accidents or Emergencies.

#### **Opportunity Classes**:

Any Opportunity Classes offered will include "Opportunity" in the class name. These classes will follow all USEF Dressage Division rules and applicable USEF General Rules, including dress and saddlery.

- Opportunity Classes are for <u>entry level participants</u> and these classes are judged by USEF licensed judges or FEI dressage judges.
- Horses and/or riders may enter in Opportunity Classes and cross enter into the rated/recognized classes at this competition. All applicable fees and membership requirements will apply.
- Opportunity Classes cannot be used as qualifying classes for the Great American/USDF Regional Championships.
- Freestyles or Test of Choice classes are not offered as Opportunity classes.
- Riders, Owners, Trainers and Coaches entered only in these classes are exempt from both USEF and USDF membership requirements and are not required to pay Show Pass/non-member fees but are required to list the USEF/USDF membership numbers if the participants are members.
- Horses entered only in these classes:
  - Are exempt from the USEF fee, including the Equine Drugs and Medication fee. Horses entered only in these classes are still subject to and must comply with the Drugs and Medication rules and are subject to drug testing.
  - Are not required to have either a USEF or USDF Horse Identification (HID) or Recording Number but are to list the HID or Recording numbers if the horse has been assigned these numbers.

#### **General Rules and Regulations**

"EVERY CLASS OFFERED HEREIN WHICH IS COVERED BY THE RULES AND SPECIFICATIONS OF THE CURRENT FEDERATION RULE BOOK WILL BE CONDUCTED AND JUDGED IN ACCORDANCE THEREWITH."

All questions not covered in these rules and regulations shall be decided by the show management whose decision shall be final.

• Horses by their inherent nature present a risk. This show, the management, the USEF Licensee, and the facility will not be responsible for any loss or damage or injury to horses exhibited, or for any article of any kind or nature that may be lost or destroyed, or in any way injured. Each exhibitor will be responsible for any injury that may be occasioned to any person, horse owned or exhibited by said exhibitor and shall indemnify the show, the management, the show committee and volunteers, the USEF Licensee, the USEF and USDF, or any member thereof, against all claims and demands, of any nature or kind, that may grow out of any injury occasioned by any horses owned or exhibited by them, or arise from the negligence of the person in charge of any such horse. All horses exhibited in this show participate entirely at the owner's risk.

Neither the Organizing Committee, show volunteers and staff, the facility or its owners, any host GMO, USEF or USDF or their members will be responsible for any damage, injury, or loss to persons, horses, or property of exhibitors or spectators. All owners and competitors are personally responsible for damages to third parties caused by themselves, their employees, their agents or their horses. They are therefore strongly advised to take out third-party insurance providing full coverage for participation in equestrian events at home and abroad, and to keep the policy up to date.

- Exhibitors are notified that any act of discourtesy or disobedience to the judges or officials, on the part of the owner, manager, rider, or groom shall disqualify the horse, and the owner shall forfeit their entry fee and other fees.
- Show Management reserves the right to vary or add officials and refuse any entry for a cause; to disqualify any exhibitor and/or his or her horse for cause; to cause an exhibitor to forfeit his or her ribbons and winnings for cause; to return any entry and/or stall fee before or during the show for cause; all without being liable for damage or compensation. Show management reserves to itself the power to prohibit any person from attending or showing a horse in the ring and to remove any groom or horse from the show without being liable for compensation. Show management reserves the right to make any changes deemed necessary for the safe and efficient conduct of this competition.
- In accordance with the 1989 Federal Waste Tracking Act, which restricts the disposal of medical waste, biohazardous medical waste containers will be provided in the stable area. All exhibitors and their agents are responsible for the proper disposal of this waste.
- No person will be allowed in the show ring during the time of judging except the exhibitor and those having official or requested duties to perform.
- It is the tradition of the show that riders be correctly attired for the class in question, that attendants be neatly dressed and the horses properly presented. Management may in its discretion bar any person from entering the ring if not suitable presented to appear before an audience.
- Exhibitors should exercise extreme caution before medicating their horses and should be aware of the US EQUESTRIAN FEDERATION rules governing drugs and medications.

- A horse must wear their Bridle Tag Number at all times when not in a stall; which includes when a horse is being ridden or exercised.
- Classes may not necessarily be run in the order listed in the prize lists.

By entering a Federation-licensed Competition and signing this entry blank as the Owner, Lessee, Trainer, Manager, Agent, Coach, Driver, Rider, Handler, Vaulter or Longeur and on behalf of myself and my principals, representatives, employees and agents, I agree that I am subject to the Bylaws and Rules of The United States Equestrian Federation, Inc. (the "Federation") and the local rules of the Bozeman Dressage Society Dressage Under the Big Sky III & IV Competition.


I represent that I am eligible to enter and/or participate under the Rules, and every horse I am entering is eligible as entered.

I hereby expressly and irrevocably waive and release any rights in connection with such use, including any claim to compensation, invasion of privacy, right of publicity, or to misappropriation. The construction and application of Federation rules are governed by the laws of the State of New York, and any action instituted against the Federation must be filed in New York State. See GR908.4.

#### **MEMBERSHIP STATEMENT**

Life, senior active and junior active members shall be eligible to participate in all classes at Regular Competitions, Eventing Competitions at the Modified Level or above and Combined Driving Competitions at the Advanced Level, Dressage, Reining and Vaulting Competitions and Endurance Rides. A nonmember may participate as a handler, rider, driver, owner, lessee, agent, coach or trainer at Regular Competitions, Eventing Competitions, Dressage Competitions, Reining Competitions and Combined Driving Competitions upon payment of a \$45 Show Pass fee. Participants in the following classes are exempted from the Requirements of this rule: 1) leadline; 2) exhibitions; 3) games and races; 4) classes for 4-H members; 5) walk trot (exception: Friesian performance FR218) and academy classes (academy classes are classes limited to horses used regularly in a lesson program); 6) USDF introductory level tests, pas de deux and quadrille classes; 7) NRHA Endorsed Reining Competitions; 8) Opportunity classes; 9) citizens of other nations who have proof, in English, of current membership in good standing of their own National Federation; 10) USEA beginner novice division; and 11) assistant handlers in Dressage Sport Horse Breeding classes.

#### Regional Adult Amateur Equitation Program

The USDF Regional Adult Amateur Equitation Program recognizes adult amateurs competing in equitation and promotes correct seat, position, and use of the aids in dressage. An Adult Amateur Equitation Regional Final class presented by Big Dee's Tack and Vet Supply will be held in conjunction with each of the nine USDF Regional Dressage Championship competitions, providing adult amateurs with additional opportunity for recognition.

Adult amateurs wishing to qualify to compete in an Adult Amateur Equitation Regional Final may do so by meeting the following requirements.

#### Qualifying Requirements

- To be eligible for the USDF Adult Amateur Equitation Regional Final class, rider must have
  - a) Earned a score of 70% or higher in any dressage seat equitation class (except walk/trot) at a USEF-licensed/USDFrecognized Dressage competition within the qualifying period of the applicable regional championship.
  - b) Qualified to compete in any regional dressage championship class (excluding freestyles)

#### Membership Requirements

- Rider must have a USDF Participating Membership at the time the qualifying score is earned, and at the time of the Regional Final class.
- Rider must be an adult amateur, in accordance with GR1306 of the USEF rules, and be designated with USEF as an adult amateur when the score is earned, and at the time of the Regional Final class.
- Owner must have a USDF Participating or Business Membership when the qualifying score is earned, and at the time of the Regional Final class.
- Horse must have a USDF Lifetime Horse Registration when the qualifying score is earned, and at the time of the Regional Final class.



<u>USDF Membership Benefits</u>: USDF is dedicated to education, the recognition of achievement, and promotion of dressage. For details on member benefits, including educational programs, awards, and other opportunities, refer to the USDF Member Guide or the USDF website at www.usdf.org.

#### Membership Requirements for USEF-licensed/USDF-recognized Competitions: Owners and riders, including foreign riders

and owners who are not residents of the US, wishing to participate in a USEF-licensed/USDF-recognized competition as a rider or owner/lessee, must have either a USDF Group Membership (GM), Participating Membership (PM), or have a USDF Non-Member (NM) identification number and pay the USDF Non-Member (NM) fee. (Note: USDF Business Members can own horses but cannot compete as riders with their USDF Business Membership.)

Horses competing at USEF-licensed/USDF-recognized competitions must have either a USDF Horse Identification (HID) number or a USDF Lifetime Horse Registration (LHR). Proper credentials or verification certificates must be presented to the competition secretary.

Riders and owners wishing to participate in a USEF-licensed/USDF-recognized competition, and not able to present the competition secretary with verification of a USDF membership or NM identification, and USDF LHR or USDF HID, must complete a USDF Competition Affidavit Form and pay the \$5 affidavit filing fee. A copy of a completed affidavit form from another competition may also be used for verification purposes for up to 60 days. (Exception: Affidavits cannot be used at Great American Insurance Group/USDF Regional Dressage Championships.)

#### **Exceptions:**

- Horses competing only in Individual Breed Classes (IBCs) at DSHB competitions, sires and dams of horses in DSHB group classes, where those
  sires or dams are not actually competing in the same competition, horses competing only in breed restricted dressage or DSHB classes at
  Regular Competitions (e.g. all Arabian, all Friesian, or all Morgan classes), or in USDF Introductory Level tests, pas de deux or quadrille, are
  exempt from this requirement. Also exempt are horses ridden in leadline, exhibitions, games and races, classes for 4-H members, walk-trot,
  academy, and opportunity classes.
- Riders and owners/lessees competing only in classes which are exempt from the USDF HID requirements are also exempt from the USDF NM
  identification number and NM fee requirements. Also exempt are handlers of horses competing in DSHB In-Hand or Group classes.

#### **Memberships Defined**

**Participating Membership (PM):** A membership issued to an individual directly by USDF. The membership year is December 1 through November 30. PMs are available for 1-year (\$90), 5-years (\$360), or life (\$1,800). A USDF Youth Participating Membership (YPM) is available for individuals who have not reached their 21<sup>st</sup> birthday by December 1 of the current membership year (\$72). A PM allows the member to compete at USEF-licensed/USDF-recognized competitions and to participate as a rider and/or owner/lessee for all Adequan<sup>®</sup>/USDF Year-End Awards and the Great American Insurance Group/USDF Regional Dressage Championship program.

**Group Membership (GM):** A membership issued to an individual by USDF when the member name and dues are submitted to USDF through an affiliate Group Member Organization (GMO). The GM year begins December 1 and ends November 30. A GM allows the member to compete at USEF-licensed/USDF-recognized competitions and participate in the USDF Rider Awards Program and the USDF Regional Schooling Show Awards Program. **Business Membership (BM):** A membership that runs December 1 through November 30 and is issued to a business or organization directly by USDF. The USDF BM (\$240) offers a wider variety of advertising benefits. BMs satisfy requirements of horse ownership only.

**Non-Member (NM) Identification Number:** For each USDF NM owner/lessee and USDF NM rider there will be a USDF NM fee of \$35 per competition that must be collected by the show secretary and submitted to USDF, along with the USDF Report of Fees document and the \$5 affidavit fee and Competition Affidavit Form if the person cannot provide a copy of their USDF NM card. Owners/lessees or riders exempt from the NM number requirements are also exempt from paying the USDF NM fee. If there are multiple owners of a horse and all are NMs, only one of the owners must pay the NM fee. If the horse has at least one owner who is a current USDF PM, GM, or BM there is no NM fee assessed. Competition management will be invoiced for all applicable USDF NM fees not received with the USDF post-competition paperwork, along with a report listing all USDF NMs. Competition management is then required to submit the NM fees within 30 days to the USDF. An individual with a USDF NM identification number is not eligible for any USDF membership benefits. Once a USDF NM number has been assigned, a USDF NM card can be obtained from the USDF website.

Horse Identification (HID) Number: A one-time tracking number for horses (\$35). Scores earned by a horse with an HID number will be recorded, but will NOT be counted towards Adequan®/USDF Year-End Awards. A horse with an HID number is not eligible to compete in Great American Insurance Group/USDF Regional qualifying or championship classes. An HID number can be upgraded to a Lifetime Horse Registration (LHR) for a fee of \$80. If a horse has a USDF LHR it does not need an HID number. An HID number is a one-time fee that does not need to be renewed.

Lifetime Horse Registration (LHR): A horse with an LHR (\$115) is eligible for Adequan<sup>®</sup>/USDF Year-End Awards, and eligible to compete in Great American Insurance Group/USDF Regional qualifying and championship classes, assuming requirements for the owner and rider are met. If a horse has an LHR it does not need an HID number. An LHR does not need to be renewed.

#### How to Join USDF

Applications for USDF Participating Membership (PM), Business Membership (BM), Horse Identification (HID) number, and Lifetime Horse Registration (LHR) may be found in the following locations:

- On the USDF website: www.usdf.org. You can submit the application online or download the form and fax or mail it to the USDF office.
- In the show office at USEF-licensed/USDF-recognized competitions classified by USEF as Dressage Competitions, and Regular Competitions which are open to all breeds.
- By calling or writing the USDF office at (859) 971-2277, 4051 Iron Works Parkway, Lexington, KY 40511

The effective date of membership is the date the form and correct fees are received in the USDF office or, if applying at a competition, the date accepted by the competition secretary, provided the application is signed and dated by the competition secretary, member, and/or horse owner on that same day.



### 2021 Great American Insurance Group/USDF Regional Dressage Championships

A single Regional Dressage Championship program organized by the United States Dressage Federation (USDF), and recognized by the United States Equestrian Federation, Inc. (USEF), will be held in each of the nine USDF regions. In addition, Alaska and Hawaii may each hold state championships if an official request from a Group Member Organization (GMO) is received by April 1 of the prior year. The Regional Championship Program Rules can be found on the USDF website at <u>www.usdf.org</u>. Please refer to the 2021 USDF Member Guide for the comprehensive list of rules and requirements for this program.

#### Membership/Registration Requirements for Qualifying and Championships

All memberships and registrations/recordings must be correct and current at the time qualifying scores are earned and at the time of the championships.

Rider:

• Must have a USDF Participating\* Membership (PM).

• Must have a USEF membership (Junior Active, Senior Active, or Life).

Horse:

- Must have a USDF Lifetime Horse Registration (LHR).
- Must have a USEF (Annual or Lifetime) Horse recording.
- USDF horse registration and USEF horse recording must be in the name(s) of the current owner(s) or lessee(s). A horse is not required to have breed registry papers.

Owner:

- Must have a USDF Participating or Business Membership and a USEF membership (Junior Active, Senior Active, Life, or Recorded Farm (with Active Farm Owner)). If the horse has more than one owner, at least one owner must have both active USEF membership and active USDF Participating or Business Membership and must be the owner of record with USEF and USDF. For a business or farm to be the valid owner under this requirement, it must be listed as an owner of the horse with both USEF and USDF.
- \* PMs are USDF members who join USDF directly. USDF Group Members (GM) are ineligible.

**Minimum Qualifying Scores:** One set of nationally-standardized qualifying scores has been established for all USEF/USDF Regional Championships, for Training Level through Grand Prix, in three divisions: open, adult amateur and junior/young rider. FEI Junior and FEI Young Rider classes have only one respective division. Freestyles have only open divisions.

# WAIVER AND RELEASE OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT

For and in consideration of United States Equestrian Federation, Inc. dba US Equestrian ("USEF") allowing me, the undersigned, to participate in any capacity (including as a rider, driver, handler, vaulter, longeur, lessee, owner, agent, coach, official, trainer or volunteer) in a USEF sanctioned, licensed or approved event or activity, including but not limited to equestrian clinics, practices, shows, competitions and related or incidental activities and ("USEF Event" or "USEF Events"); I, for myself, and on behalf of my spouse, children, heirs and next of kin,

and any legal and personal representatives, executors, administrators, successors,, and assigns, hereby agree to and make the following contractual representations pursuant to this Agreement (the "Agreement"):

A. RULES AND REGULATIONS: I hereby agree to be bound and abide by the rules, regulations, and policies of USEF as published in the USEF Rule Book and on the website at www.usef.org, as amended from time to time.

B. ACKNOWLEDGMENT OF RISK: I knowingly, willingly, and voluntarily acknowledge the inherent risks associated with the sport of equestrian and know that horseback riding and related equestrian activities are inherently dangerous, and that participation in any USEF Event involves risks and dangers including, without limitation, the potential for serious bodily injury (including broken bones, head or neck injuries), sickness and disease (including communicable diseases), trauma, pain & suffering, permanent disability, paralysis and death; loss of or damage to personal property (including my mount & equipment) arising out of the unpredictable behavior of horses; exposure to extreme conditions and circumstances; accidents involving other participants, event staff, volunteers or spectators; contact or collision with other participants and horses, natural or manmade objects; adverse weather conditions; facilities issues and premises conditions; failure of protective equipment (including helmets); inadequate safety measures; participants of varying skill levels; situations beyond the immediate control of the USEF Event organizers and competition management; and other undefined, not readily foreseeable and presently unknown risks and dangers ("Risks").
